# **CONDITIONS OF PARTICIPATION**

The conditions for participating in the InterClassics Brussels 2020 (hereinafter: the in the following Conditions of Participation and in the "General Regulations governing participation in trade fairs and exhibitions organized by or in collaboration with MECC Maastricht B.V. (hereinafter: General Regulations).

# Organization

The Exhibition shall be organized by MECC Maastricht B.V. (hereinafter and in the General Regulations: the Organizer).

#### Time and place

The Exhibition shall be held at the Brussels Expo, Place de Belgique 1, 1020, Brussels, Belgium from Friday, November 20th 2020 until Sunday, November 22nd 2020.

### Opening hours

The Exhibition shall be open to visitors on Friday November 20<sup>th</sup> 2020 from 10.00 a.m. to 9.00 p.m., on Saturday, November 21<sup>st</sup> and Sunday, November 22<sup>nd</sup> 2020, from 10.00 a.m. to 6.00 p.m. The building is open to participants each exhibition day from one hour before opening time until one hour after closing time.

#### Registration

**Participants** 

Registration is exclusively on an individual basis. Combined requests may be entered for the approval of the organisation. The exhibition organiser will only consider fully completed registration forms. To bring in cars for TopMobiel, approval by the organiser is needed.

## **Exhibition programme**

The exhibition will only show merchandise and services which, according to the organiser, correspond with the purpose of the exhibition, which is to present the visiting public with a most varied and representative overview of the offer of old-timers, classic cars, related articles and services, such as parts, tools, literature, clothing, automobilia, restoration, insurance, lease, valuation and maintenance services. The construction year of the automobiles placed on exhibition must be prior to 1990. Exceptions only will be made in consultation with the organisor. TopMobiel also invites exhibitors with lifestyle products. This will be evaluated by the organisor, who reserve the right to either add further quality requirements to possible participation or to partly or entirely exclude offered merchandise and/or services from the exhibition.

The merchandise and services as described under "Exhibition programme" may be offered by professional and private traders, collectors, manufacturers, importers, garage owners/managers and people involved in the automobile industry. TopMobiel also invites exhibitors with lifestyle products.

### Stand rental InterClassics (prices for three days)

Rental price for sale/ promotion of classic cars by car dealers and restoration companies is € 45,00 excluding VAT per m² including carpet. Rental price for sale/ promotion of Art Galleries and Artists is € 67,50 excluding VAT per m² including carpet, black walls and 2KW electricity. Rental price for sale/ promotion of new parts and other products or services like models, literature, maintenance products, automobilia, deko-objects, clothing, accessories etc. is € 32,50 excluding VAT per m² excluding carpet. Rental price for sale/ promotion of old/used parts is € 20,00 excluding VAT per m² excluding carpet. Clubs can, in contact with the organisation, lay contant to a stand area if FEHAC, BFOV or LOF associated or related organisation part of the FIVA for € 3,00 per m² excluding carpet. The organisation decides how many m² will be allocated to the club.

# Stand rental and payment terms

Unless otherwise specified in the Participation Terms & Conditions, stand rental must be paid in 2 instalments, namely:

- 1. the application fee before or on the due date of the invoice in question;
- 2. the Participation Costs in 2 instalments:
  - 25% of the Participation Costs;
  - 100% of the Participation Costs minus the above-mentioned 25%;

before or on the due date of the invoices in question.

If the Participant does not meet his/her financial obligations, the organisers will be entitled not to proceed with the allocation of stand space, or to withdraw an existing allocation of stand space or not to make stand space available, without prejudice to the organisers' claim for full payment of the amounts due.

The organisers are entitled to contract out the collection of the amounts owed by the Participant, in which case all costs will be borne by the Participant, plus the statutory interest and extrajudicial costs of collection amounting to 15% of the principal.

# Cancellations

- The organisers reserve the right to change the dates of the shows or to cancel the show at any time because of special circumstances (force majeure), without the participant being entitled to claim compensation for any loss.
- An entry cannot be withdrawn or changed unilaterally by the participant. The organisers may grant a request for cancellation of the entry under the condition that the participant concerned pays a cancellation fee. In deviation from the provisions in section 3 sub 1 of the "General Rules", the following cancellation fee applies:
  - upon cancellation more than 365 days before the first Event build-up day: 15% of the Participation Costs;
  - upon cancellation in the period from 365 to 182 days before the first Event build-up day: 50% of the Participation Costs;
  - upon cancellation in the period from 182 to 62 days before the first Event build-up day: 75% of the Participation Costs;
  - upon cancellation in the period from 62 to 31 days before the first Event build-up day: 100% of the Participation Costs;
  - upon cancellation in the period up to and including 31 days before the first Event build-up day: 120% of the Participation Costs; or such higher amount as is due in the Organisers' opinion as compensation for the costs incurred and yet to be incurred as a result of the cancellation.

The Participation Costs are the costs payable by the Participant to the Organisers for the Stand Hire and, if applicable, the Stand Build-up plus VAT. The VAT owed on the fees will also be charged. In addition, the Participant will always owe the Application Fee. Costs incurred by the Participant to the organizers to reimburse the stand rental and, if applicable, the stand, plus VAT. If canceled for any reason whatsoever at any time, the Participant shall forfeit the registration fee, plus VAT.

# Construction, Furnishing, Dismantling

Information about building up and breaking down the stand will be published in the participants manual.

# Restitution of VAT

Under the new reverse change procedure made by the Dutch Ministry of Finance from 01-01-2011, MECC Maastricht must include customers' VAT number on its invoices. If a foreign customer (within Europe) qualifies as a VAT-business, Dutch VAT will no longer be charged (=mandatory reverse change procedure). If a foreign customer (within Europe) does not qualify as a VAT-business or private individual, Dutch VAT WILL be charged. For more information www.mecc.nl.
